- ✓ Demo provided
- ✓ Manual provided with the game
  
- ✗ Disciples 3 released with different global dates
- ✗ Available only on Windows
- ✗ No DRM notification
- ✗ No advice on how ProtectDisc would affect users
- ✗ EULA is only found within the game
- ✗ All game-related information on Disciples 3 is difficult to find and navigate

### 2. Privacy Policy

*Looking at Disciples 3's Privacy Policy.*

- ✓ Privacy Policy not required

### 3. EULA TOS

*Looking at Disciples 3's End User License Agreement.*

- ✓ Permitted to create free "mods" of Disciples 3
- ✓ Can opt-out of any monitoring services / software
- ✓ Won't blacklist specific background services or software
- ✓ Users can initiate legal action if the arbitration process fails
- ✓ Users can criticise or provide criticism about the game without reprisals
  
- ✗ EULA / TOS is only found within the game.

**Note:** 1,660 words found in Disciple 3's EULA.

**Note:** Limited warranties, waivers of liability and indemnity are commonly found within many software EULAs and TOSs

## 4. Setup / Install

**Note:** ProtectDisc will install system drives in both the /AppData/Roaming/ and /Windows/System32/Drivers/ folders.

## 5. Updates / Patching

**Note:** The game was patched to 1.06 just after installation of Disciples 3.

## 6. DRM & Activation

- ✗ EULA / TOS only covers Disciples 3 (and not ProtectDisc)
- ✗ Difficult to read, understand and is inconsistently worded
- ✗ Drafted to only abide by the laws of the UK
- ✗ Users not visibly notified of any changes made to the EULA / TOS
- ✗ Can't review and query changes made to the EULA / TOS
- ✗ License to play the game only provided
- ✗ No refunds or exchanges for purchased games
- ✗ Replacement copies provided for a fee
- ✗ Terms and conditions for ProtectDisc DRM aren't clearly defined
- ✗ Circumvention of ProtectDisc DRM prohibited
- ✗ Back-ups aren't permitted as per ProtectDisc DRM's capabilities
- ✗ Disciples 3's source code isn't to be modified or reverse-engineered
- ✗ Warranties waived (excluding physical merchantability warranties)
- ✗ Cover waived against any unforeseeable damages, disruptions of service
- ✗ Termination process dictated by Kalypso Media

*Looking at how Disciples 3 is installed on Windows PCs only.*

- ✓ Custom installation options are provided
- ✓ Currently-executing background services won't interfere with installation
- ✓ Error-free installation
- ✓ Installation completed within 20 minutes
- ✗ No installation logs of files and registry keys
- ✗ Extra ProtectDisc DRM files found in /AppData/Roaming/ folders
- ✗ Extra game and DRM files found in /Windows/System32/Drivers/

*Looking at how Disciples 3 is patched prior, during and after gameplay.*

- ✓ Can opt-in / opt-out of automatic updates
- ✓ Day-one patch optional
- ✓ Can play the game unpatched
- ✓ No other DRM files or registry keys are installed
- ✓ Can install patches manually
- ✗ Notifications not provided for availability of game patches
- ✗ No installation logs of files and registry keys
- ✗ Rollback option not provided
- ✗ No plans to sunset ProtectDisc DRM

*Looking at ProtectDisc DRM in relation to Disciples 3 and its effects on Windows PCs only.*

- ✓ Won't interfere with currently-executing background services or software
- ✓ Firewall and AV settings aren't modified

**Note:** This version of ProtectDisc is implemented as a disc-verification DRM only.

## 7. Gameplay Experience

**Note:** Disciples 3 will connect to Verisign only if connected to the Internet.

**Note:** Manual settings for Disciples 3 can be found at \Program Files (x86)\Kalypso Media\Disciples 3\Save\

- ✓ User account not required
- ✓ Unlimited online activations to any one PC
- ✓ Can play single-player game offline
- ✓ Only ProtectDisc DRM is implemented
- ✓ Unlimited hardware activations
- ✓ Unlimited installations
- ✓ Activation is simple and hassle-free
  
- ✗ No instructions provided on the activation process
- ✗ Can't verify the safety and reliability of the activation process
- ✗ Activation pathway isn't explained
- ✗ No support or troubleshooting process

*Looking at the gameplay aspects of Disciples 3 and how it interacts with PC Windows.*

- ✓ Can play on minimum specs
- ✓ Suitable options to modify video settings
- ✓ Can customise controls
- ✓ Can play in windowed mode
- ✓ Can play offline
- ✓ Won't "phone home"
- ✓ Can play without connectivity issues on an ADSL connection
- ✓ Can play error-free for more than 5hrs
- ✓ Won't interfere with services and background software
- ✓ Will resume at the last checkpoint
- ✓ Can play on more than one PC simultaneously
- ✓ Can modify savegame and/or ini file
  
- ✗ Requires original copy to play the game
- ✗ Constant disc verification
- ✗ Only playable on mouse and keyboard
- ✗ DRM and monitoring services will operate during and after gameplay

## 8. PC Checkup

*Looking at whether Disciples 3 will modify certain PC settings without users permission / consent.*

- ✓ PC clean after scanning for viruses
- ✓ PC clean after scanning for malware and spyware
- ✓ PC clean after scanning for rootkits
- ✓ HOSTS wasn't modified
- ✓ Played Disciples 3 without major errors
- ✓ Start-up settings remain unaltered
- ✓ No DRM / monitoring services running in the background after shutting down
- ✓ System configuration files remain unaltered

## 9. Removal Uninstall

Looking at how clean, efficient and effective the removal process is for Disciples 3 (How much legacy material is there after the removal of Disciples 3?)

- ✓ Savegames retained
- ✗ Will need to uninstall the game via. Control Panel
- ✗ ProtectDisc DRM files and registry keys will remain.

## 10. Customer Support

Looking at the customer support side of Disciples 3 through Kalypso Media.

- ✓ Customer service / support found in one place at Kalypso Media
- ✓ Kalypso Media's site is easy to use and navigate
- ✓ Info is easy to read and understand
- ✓ Consumers can initiate legal action if arbitration process fails
- ✗ No option provided for giving feedback on the service of customer support
